

# YMCA MENDIP

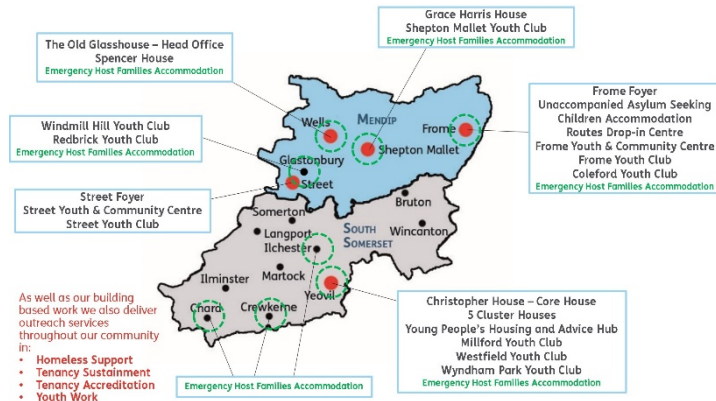
WORKING IN MENDIP &
